A BILL ENTITLED

1 AN ACT concerning

2 **Washington Suburban Sanitary Commission – Plumbing and Fuel Gas Services**
3 **– Licenses and Penalties**

4 **PG/MC 109–22**

5 FOR the purpose of prohibiting a person from providing, attempting to provide, or offering
6 to provide certain plumbing services in any area of Montgomery County or Prince
7 George’s County under the regulatory jurisdiction of the Washington Suburban
8 Sanitary Commission without a license from the Commission; prohibiting a person
9 from assisting, attempting to assist, or offering to assist in providing certain fuel gas
10 services in any area of Montgomery County or Prince George’s County under the
11 regulatory jurisdiction of the Commission without a license from the Commission;
12 authorizing the Commission’s Plumbing and Fuel Gas Board to deny a license to an
13 applicant, reprimand a licensee, or suspend or revoke a license under certain
14 circumstances; authorizing the Board to impose a certain penalty for certain
15 violations; requiring the Board to consider certain factors in determining the amount
16 of a certain penalty; and generally relating to the Washington Suburban Sanitary
17 Commission.

2 article;
- 3 (2) regulations governing plumbing adopted under § 17–403, Title 24,
4 Subtitle 1, § 26–102, or § 26–204 of this article;
- 5 (3) regulations governing erosion and sediment control for utility
6 construction adopted under § 17–403 of this article and § 4–105 of the Environment Article;
- 7 (4) regulations governing gas fitting adopted under § 17–404 of this article;
- 8 (5) regulations governing required permits for public utility construction
9 adopted under §§ 27–101, 27–107, and 27–108 of this article;
- 10 (6) regulations governing the Commission Pretreatment Program adopted
11 under § 17–403 of this article and § 9–332 of the Environment Article; or
- 12 (7) any other regulation adopted in accordance with § 17–406 of this article.

13 (c) (1) (i) A person who violates any provision of a regulation listed in
14 subsection (b) of this section has committed a Commission infraction and on delivery of a
15 citation by the Commission under subsection (d)(1) of this section shall pay to the
16 Commission a civil fine in the amount of:

- 17 1. for a first violation of the regulation, \$250;
- 18 2. for a second violation of the regulation, \$500;
- 19 3. for a third violation of the regulation, \$750; and
- 20 4. for a fourth or subsequent violation, \$1,000.

21 (ii) Each day that a violation of the regulation remains uncorrected
22 is a separate Commission infraction subject to an additional citation and fine in the amount
23 of \$250.

24 (2) (i) The payment due date for the fine may not be less than 10 or
25 more than 20 calendar days after the date of delivery of the citation.

1 (ii) The recipient of the citation may pay the fine before the payment
2 due date specified in the citation.

3 (d) (1) After verifying a Commission infraction the enforcement official shall
4 deliver the citation to any person charged with committing the Commission infraction in
5 accordance with the enforcement procedures of the regulations.

6 (2) The citation shall be on a form adopted by the Commission and shall
7 include:

8 (i) the date of delivery of the citation;

9 (ii) the name and address of the person charged;

10 (iii) the specific provision of the regulations that has been violated;

11 (iv) the nature of the Commission infraction;

12 (v) the location and time that the Commission infraction occurred;

13 (vi) the amount of the civil fine assessed for the Commission
14 infraction;

15 (vii) the manner, location, and time in which the fine may be paid to
16 the Commission;

17 (viii) a statement that each day that a violation continues is a separate
18 Commission infraction subject to additional citation;

19 (ix) the name, business address, title, and telephone number of the
20 enforcement official who issued the citation; and

21 (x) notice of the person's right to a trial for the Commission
22 infraction and instructions and time limits for that election.

23 (e) (1) A person who receives a citation for a Commission infraction under this
24 section may elect to stand trial by filing with the Commission a notice of the person's intent

1 to stand trial.

2 (2) The notice of intent to stand trial shall be given at least 5 days before
3 the payment due date specified in the citation.

4 (3) On receipt of the notice of intent to stand trial, the Commission shall
5 forward to the District Court having venue a copy of the citation and a copy of the notice of
6 intent to stand trial that was filed by the person who received the citation.

7 (4) On receipt of the citation and the notice of intent to stand trial, the
8 District Court shall schedule the case for trial and notify the defendant and Commission of
9 the trial date.

10 (5) The District Court shall remit to the Commission all fines, penalties, or
11 forfeitures the Court collects for Commission infractions.

12 (f) (1) If a person who receives a citation for a Commission infraction fails to
13 pay the fine by the payment due date specified in the citation and fails to file a notice of the
14 person's intent to stand trial for the offense:

15 (i) the person is liable for the assessed fine; and

16 (ii) the Commission shall send a notice of the Commission infraction
17 to the person's last known address.

18 (2) (i) If the fine is not paid within 35 days after the date of the notice,
19 the Commission may request adjudication of the case through the District Court, which
20 may include the filing of a demand for judgment on affidavit.

21 (ii) On receipt of the request for adjudication, the District Court shall
22 schedule the case for trial and summon the defendant to appear.

23 (3) If the defendant fails to respond to the summons and the Commission
24 has made a proper demand for judgment on affidavit, the District Court shall enter
25 judgment against the defendant in favor of the Commission in the amount then due.

26 (g) (1) For the purpose of this section, a Commission infraction is a civil
27 offense.

1 (2) The adjudication of a Commission infraction:

2 (i) is not a criminal conviction; and

3 (ii) does not impose any of the civil disabilities ordinarily imposed by
4 a criminal conviction.

5 (h) In a proceeding for a Commission infraction before the District Court, the
6 violation shall be prosecuted in the same manner and to the same extent provided for
7 municipal infractions under §§ 6–108 through 6–110, 6–112, and 6–114 of the Local
8 Government Article.

10 (A) (1) **IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
11 **INDICATED.**

12 (2) (I) **“PROVIDE FUEL GAS SERVICES” MEANS TO INSTALL,**
13 **MAINTAIN, ALTER, REPAIR, REMOVE, OR REPLACE PROPANE OR NATURAL GAS**
14 **PIPING, GAS UTILIZATION EQUIPMENT, GAS–FIRED EQUIPMENT, APPLIANCES, OR**
15 **APPURTENANCES IN CONNECTION WITH A PROPANE OR NATURAL GAS SUPPLY**
16 **SYSTEM DOWNSTREAM OF THE POINT OF DELIVERY OF THE GAS.**

17 (II) **“PROVIDE FUEL GAS SERVICES” DOES NOT INCLUDE THE**
18 **INSTALLATION, MAINTENANCE, ALTERATION, REPAIR, REMOVAL, OR REPLACEMENT**
19 **OF ANY OF THE FOLLOWING WITH RESPECT TO A PLUMBING WATER SUPPLY AND**
20 **DRAINAGE SYSTEM:**

21 1. **FIXTURES THAT REQUIRE ADDITIONAL ENERGY**
22 **SOURCES, INCLUDING CLOTHES WASHERS, DISHWASHERS, FOOD GRINDERS,**
23 **HUMIDIFIERS, ICE PUMPS, STERILIZERS, WATER COOLERS, AND WATER HEATERS;**
24 **OR**

25 2. **OPERATIONAL DEVICES, INCLUDING AERATORS,**
26 **BACKFLOW PREVENTERS, EXPANSION TANKS, FILTERS, FLOW CONTROLS, HEAT**
27 **EXCHANGERS, INTERCEPTORS, METERS, SEPARATORS, AND RELIEF VALVES.**

1 **(3) (I) “PROVIDE PLUMBING SERVICES” MEANS TO INSTALL,**
2 **MAINTAIN, EXTEND, ALTER, OR REMOVE PIPING, A PLUMBING FIXTURE, A PLUMBING**
3 **APPLIANCE, A PLUMBING APPURTENANCE, OR OTHER PLUMBING APPARATUS:**

4 **1. WITHIN OR ADJACENT TO A BUILDING, STRUCTURE,**
5 **OR PROPERTY; AND**

6 **2. IN CONNECTION WITH:**

7 **A. A PUBLIC OR PRIVATE DISPOSAL SYSTEM, SANITARY**
8 **DRAINAGE FACILITY, OR STORM DRAINAGE FACILITY;**

9 **B. A VENTING SYSTEM; OR**

10 **C. A PUBLIC OR PRIVATE WATER SUPPLY SYSTEM.**

11 **(II) EXCEPT FOR THE FIRST CONNECTION TO A POTABLE WATER**
12 **SUPPLY THAT IS DOWNSTREAM OF A BACKFLOW PREVENTER AND THE FINAL**
13 **CONNECTION THAT DISCHARGES INDIRECTLY INTO A PUBLIC OR PRIVATE DISPOSAL**
14 **SYSTEM, SANITARY DRAINAGE FACILITY, OR STORM DRAINAGE FACILITY, “PROVIDE**
15 **PLUMBING SERVICES” DOES NOT INCLUDE USING PIPING, EQUIPMENT, OR**
16 **MATERIAL ONLY FOR:**

17 **1. ENVIRONMENTAL CONTROL;**

18 **2. THE INCORPORATION OF A LIQUID OR A GAS INTO A**
19 **PRODUCT OR A PROCESS, INCLUDING PRODUCT DEVELOPMENT, IN THE**
20 **MANUFACTURING OR STORAGE OF A PRODUCT;**

21 **3. THE INSTALLATION, ALTERATION, REPAIR, OR**
22 **REMOVAL OF AN AUTOMATIC SPRINKLER SYSTEM, RELATED APPARATUS, OR**
23 **STANDPIPE THAT IS USED ONLY FOR FIRE PROTECTION; OR**

24 **4. AN OVERHEAD OR UNDERGROUND FIRE LINE**
25 **BEGINNING FROM WHERE WATER IS USED ONLY FOR FIRE PROTECTION.**

26 **(B) A PERSON MAY NOT PROVIDE, ATTEMPT TO PROVIDE, OR OFFER TO**
27 **PROVIDE PLUMBING SERVICES IN ANY AREA OF MONTGOMERY COUNTY OR PRINCE**

1 **GEORGE’S COUNTY UNDER THE REGULATORY JURISDICTION OF THE COMMISSION**
2 **WITHOUT A LICENSE FROM THE COMMISSION.**

3 **(C) A PERSON MAY NOT ASSIST, ATTEMPT TO ASSIST, OR OFFER TO ASSIST**
4 **IN PROVIDING FUEL GAS SERVICES IN ANY AREA OF MONTGOMERY COUNTY OR**
5 **PRINCE GEORGE’S COUNTY UNDER THE REGULATORY JURISDICTION OF THE**
6 **COMMISSION WITHOUT A LICENSE FROM THE COMMISSION.**

7 **(D) (1) SUBJECT TO THE PROVISIONS OF § 10–226(C) OF THE STATE**
8 **GOVERNMENT ARTICLE AND PARAGRAPH (2) OF THIS SUBSECTION, THE**
9 **COMMISSION’S PLUMBING AND FUEL GAS BOARD MAY DENY A LICENSE TO ANY**
10 **APPLICANT, REPRIMAND A LICENSEE, OR SUSPEND OR REVOKE A LICENSE IF THE**
11 **LICENSEE:**

12 **(I) FRAUDULENTLY OR DECEPTIVELY OBTAINS OR ATTEMPTS**
13 **TO OBTAIN A LICENSE OR PERMIT FOR THE APPLICANT OR LICENSEE OR FOR**
14 **ANOTHER;**

15 **(II) FRAUDULENTLY OR DECEPTIVELY USES A LICENSE;**

16 **(III) IS GUILTY OF GROSS NEGLIGENCE, INCOMPETENCE, OR**
17 **MISCONDUCT WHILE PROVIDING PLUMBING OR FUEL GAS SERVICES OR ASSISTING**
18 **IN PROVIDING PLUMBING OR FUEL GAS SERVICES;**

19 **(IV) IS GUILTY OF VIOLATING THE COMMISSION’S PLUMBING**
20 **AND FUEL GAS REGULATIONS ADOPTED UNDER TITLE 17, SUBTITLE 4 OF THIS**
21 **ARTICLE WHILE PROVIDING PLUMBING OR FUEL GAS SERVICES OR ASSISTING IN**
22 **PROVIDING PLUMBING OR FUEL GAS SERVICES; OR**

23 **(V) IS GUILTY OF AN UNFAIR, ABUSIVE, OR DECEPTIVE TRADE**
24 **PRACTICE, AS DEFINED IN § 13–301 OF THE COMMERCIAL LAW ARTICLE.**

25 **(2) (I) IN LIEU OF OR IN ADDITION TO REPRIMANDING A LICENSEE**
26 **OR SUSPENDING OR REVOKING A LICENSE UNDER PARAGRAPH (1) OF THIS**
27 **SUBSECTION, AND IN ADDITION TO THE PROVISIONS OF § 29–101 OF THIS TITLE, THE**
28 **COMMISSION’S PLUMBING AND FUEL GAS BOARD MAY IMPOSE A PENALTY NOT**
29 **EXCEEDING \$5,000 FOR EACH VIOLATION.**

1 **(II) TO DETERMINE THE AMOUNT OF THE PENALTY IMPOSED**
2 **UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH, THE BOARD SHALL CONSIDER:**

- 3 **1. THE SERIOUSNESS OF THE VIOLATION;**
4 **2. THE HARM CAUSED BY THE VIOLATION;**
5 **3. THE GOOD FAITH OF THE LICENSEE; AND**
6 **4. ANY HISTORY OF PREVIOUS VIOLATIONS BY THE**
7 **LICENSEE.**

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
9 October 1, 2022.
