AMENDMENTS TO HOUSE BILL 1364

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 5, strike "County Executive of"; in the same line, after "County" insert "Council"; strike beginning with "to" in line 6 down through "proceedings" in line 8; strike beginning with "requiring" in line 11 down through "and" in line 13; in line 13, strike the second "the" and substitute "adequate"; and in line 14, after "funding" insert "for the People's Counsel; authorizing the Montgomery County Council to remove an individual appointed as the People's Counsel under certain circumstances".

AMENDMENT NO. 2

On page 3, in line 5, strike "COUNTY EXECUTIVE" and substitute "COUNTY COUNCIL"; strike beginning with the "TO" in line 6 down through "PLANNING" in line 13 and substitute "WHO HAS SUBSTANTIAL EXPERIENCE WITH LAND USE PROCEDURES"; strike in their entirety lines 15 through 19, inclusive, and substitute:

- "(1) IN ACCORDANCE WITH THE ACTION PLAN SPECIFIED IN THE COUNTY RACIAL EQUITY AND SOCIAL JUSTICE ACT, FOCUS ON SERVING POPULATIONS THAT HAVE BEEN TRADITIONALLY UNDERREPRESENTED, INCLUDING:
 - (I) LOW-INCOME RESIDENTS;
 - (II) RENTERS;
 - (III) RESIDENTS WITH DISABILITIES; AND

- (IV) RESIDENTS WHO SPEAK A LANGUAGE OTHER THAN ENGLISH IN THE HOME;
- (2) BE AN INDEPENDENT SOURCE OF INFORMATION TO EDUCATE RESIDENTS ON LAND USE PLANNING AND THE DEVELOPMENT REVIEW PROCESS, INCLUDING:
- (I) PROVIDING INFORMATION AND TECHNICAL ASSISTANCE ON LAND USE AND ZONING TOPICS AND PROCESSES;
- (II) PROVIDING GUIDANCE ON EFFECTIVE PARTICIPATION IN THE COUNTY LAND USE PROCESS; AND
- (III) CONDUCTING PROACTIVE OUTREACH TO RESIDENTS OF THE COUNTY;
- (3) IF REQUESTED BY PRINCIPAL PARTIES, ASSIST AND FACILITATE IMPLEMENTATION OF COMMUNITY LIAISON COMMITTEES;
- (4) PREPARE AND WIDELY DISTRIBUTE INFORMATION THROUGH APPROPRIATE METHODS;
 - (5) RESPOND TO INQUIRIES FROM COUNTY RESIDENTS; AND
- (6) PROACTIVELY MEET WITH RESIDENTS AND COMMUNITY GROUPS.";

in line 20, after "NOT" insert ":

in the same line, after "INDIVIDUAL" insert ", PUBLIC OR PRIVATE ENTITY,"; in line 21, after "PROCEEDING" insert ";

- (2) REPRESENT ANY PARTY IN A PROCEEDING INVOLVING ZONING OR LAND USE IN THE COUNTY WITHIN 1 YEAR AFTER SERVING AS PEOPLE'S COUNSEL; OR
- (3) GIVE TESTIMONY IN A PROCEEDING BEFORE A PUBLIC BODY EITHER AS A REPRESENTATIVE OR IN AN INDIVIDUAL CAPACITY";

in the same line, after "ANY" insert "<u>LEGAL OR ADMINISTRATIVE</u>"; strike beginning with "(1)" in line 22 down through "(2)" in line 24 and substitute "<u>THE PEOPLE'S</u> <u>COUNSEL SHALL PROVIDE AN ANNUAL REPORT TO THE COUNTY COUNCIL ON THE ACTIVITIES OF THE PEOPLE'S COUNSEL.</u>

<u>(F)</u>";

in line 24, after "APPROVE" insert "ADEQUATE"; in line 25, strike "AS PROVIDED FOR IN THE COMMISSION'S BUDGET PROPOSAL"; after line 25, insert:

"(G) THE COUNTY COUNCIL MAY REMOVE AN INDIVIDUAL APPOINTED TO SERVE AS THE PEOPLE'S COUNSEL FOR GOOD CAUSE BY AN AFFIRMATIVE VOTE OF SIX COUNCILMEMBERS.";

and in line 27, strike "October" and substitute "July".
