1 AN ACT concerning

2 **Montgomery County – Leghold or Body–Gripping Traps – Prohibition**

3 **MC 16–10**

4 FOR the purpose of expanding the application of the prohibition against the use,
5 setting, placement, or maintenance of a leghold or body–gripping trap in
6 Montgomery County; making a certain technical correction; making a stylistic
7 change; and generally relating to the leghold or body–gripping trap prohibition
8 in Montgomery County.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
2 MARYLAND, That the Laws of Maryland read as follows:

3 **Article – Natural Resources**

4 10–410.

5 (o) (1) In Anne Arundel, Baltimore, Howard, [Montgomery,] and Prince
6 George’s counties, a person may not use, set, place, or maintain any steel jaw leghold
7 trap on land. The steel jaw leghold trap may be used for the capture of fur-bearing
8 mammals in water only.

9 (2) This subsection does not apply to:

10 (i) Traps set on farmland by the owner of the farmland, by the
11 owner’s agent or tenant, owner’s lessee, or by any member of the owner’s or tenant’s
12 immediate family who resides on the farmland; or

13 (ii) Traps set by an authorized agent of the [Maryland Forest,
14 Park and Wildlife Service] **DEPARTMENT** who exercises the [agent’s] duties **OF THE**
15 **AGENT** for wildlife control under guidelines established by the Department.

16 **(O–1) (1) IN MONTGOMERY COUNTY, A PERSON MAY NOT USE, SET,**
17 **PLACE, OR MAINTAIN A LEGHOLD OR BODY–GRIPPING TRAP.**

18 **(2) THIS SUBSECTION DOES NOT APPLY TO A TRAP SET BY AN**
19 **AUTHORIZED AGENT OF THE DEPARTMENT WHO EXERCISES THE DUTIES OF THE**
20 **AGENT FOR WILDLIFE CONTROL UNDER GUIDELINES ESTABLISHED BY THE**
21 **DEPARTMENT.**

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
23 July 1, 2010.
