

To reach our Vision Zero goals, there are numerous municipal, county, and state agencies involved. The core group that receives the most funding and critical to Vision Zero's success are shown in the dark blue inner circle. The outer light blue circle highlights the many partner departments and agencies that have a role in creating safe streets for all roadway users. All of these groups are brought together by the County Executive's Office through the Assistant Chief Administrative Officer and Vision Zero Coordinator overseeing the initiative.

2020 ACTION PLAN – ACTION AREAS





Engineering

- Design facilities that prioritize safety as the top priority
- Key Outcome: Reductions in severe and fatal collisions in High Injury Network (HIN)



Enforcement

- Encourage safe behaviors using evidence-based high visibility enforcement
- Key Outcome: Hours of dedicated enforcement for factors contributing to severe and fatal collisions



Education

- Engage the public to promote the importance of traffic laws and safe behaviors
- Key Outcome: Increased awareness of dangerous driving, biking, and walking behaviors



Traffic Incident Management

- Ensure that when a collision occurs, prompt care is provided
- Key Outcome: Maintain response times for traffic collisions with injuries based on dept. standards



Law, Policy, and Advocacy

- Improve the way traffic safety is managed by changing codes, laws, and policies that do not align with Vision Zero
- Key Outcome: Passage of significant laws and policies required to implement Vision Zero





Middlebrook Rd	Under Construction	Quick build project for protected bike lanes and road diet is under construction and scheduled to be completed in October. Signal construction at Wisteria & Crystal Rock on schedule to be installed by October.	
Randolph Rd	Delayed due to COVID-19	Delayed due to suspension of collecting ped/bike/motor vehicle traffic volume. Study has resumed this month.	
Sam Eig Hwy	On Schedule	Data analysis and studying design alternatives underway



VISION ZERO PROJECT MAP





MCDOT and CountyStat developed an interactive project map to highlight Vision Zero related projects happening across the county.

Since the initial launch of the map, SHA projects have been included such as speed limit reductions on major highways and signal projects.

PROMOTING EQUITY IN PROJECT SELECTION



POTENTIAL SCORECARD CRITERIA RECOMMENDED BY EQUITY TASK FORCE:

- Crash data: rank projects based on need as evidenced by the high injury network
- Current state of physical infrastructure: adequacy of existing sidewalks, bike infrastructure, bus stops, lighting
- Modal priority: Prioritize vulnerable transportation modes (walking, biking, scooting, persons using mobility assistive equipment)
- Location: prioritize areas such as school walksheds, high vulnerability population such as seniors, equity emphasis areas
- History of funding: Review prior engineering and maintenance projects performed in recent years.



STREETERIES & GREENWAYS



OUTDOOR DINING AREAS (STREETERIES)






Since the beginning of the pandemic, City, County, and State Government have been expanding options for safe recreation and outdoor dining. To support restaurants and their patrons, MCDOT has set up 44 temporary "Curbside Pickup" zones in 4 areas of the county and allowed onstreet dining by closing streets and lanes in Wheaton, Silver Spring, and Bethesda, BlackRock Center for the Arts has created an outdoor dining area in Germantown, Rockville has closed Gibbs Street, and Takoma Park closed a block of Laurel Ave.

Since the beginning of the pandemic, City, County, and State Government have been expanding options for safe recreation and outdoor dining. To support recreation, the Parks Department has closed portions of parkways from Friday - Sunday to relieve trail traffic. MCDOT closed 7 roads in Silver Spring and Wheaton to through traffic for safer walking and biking routes. Residents can also request short-term block closures at the MCDOT Shared Streets website.




VISION ZERO EDUCATION & ENCOURAGEMENT



EDUCATION DURING COVID-19







With the continuation of virtual classrooms, we are retooling our education and encouragement activities. This spring, we moved our Safety Day event to a Safety Week where kids could do fun activities at home. We are currently working with the Department of Recreation to develop onbike education activities that can be done while meeting social distancing and other safety guidelines.

PROMOTING EQUITY IN OUTREACH



Recommendations from Equity Task Force:

- Culturally competent messaging: develop materials that are specific to the experiences and issues of our different communities. Ensure materials are in multiple languages and accessible to persons with disabilities.
- Find and remove barriers to engagement: Examine barriers that deter and minimize the likelihood that vulnerable populations to contacting the County to report issues or provide project input.
- **Prioritize education around schools:** Messaging can reach the child and their parents/guardians.
- Bike safety education: Provide on-bike education in MCPS.

PROMOTING EQUITY IN ENFORCEMENT


Recommendations from Equity Task Force:

- **Use judiciously:** always use in conjunction with engineering and education efforts.
- Account for roadway design: Incorporate the built environment for high visibility enforcement campaigns.
- Focus on most dangerous behaviors: Enforcement should be focused on curbing known dangerous behaviors instead of lower risk violations.
- Use data to track and improve traffic enforcement: Examine crash and traffic violation data regularly to improve consistency with decision making and guidance to patrol officers.
- Alternative punishments: Provide alternatives to paying fines.
- Implicit Bias Training: Train officers on implicit racial and ethic bias as it relates to traffic enforcement.



Commission.


HIGH VISIBILITY ENFORCEMENT
















MCPD utilizes the Maryland Highway Safety Office's high visibility enforcement (HVE) calendar to perform regular stepped up enforcement all year round. MCPD utilizes analyses from MHSO, Traffic Division data analyst, and CountyStat to identify hotspots for crashes.

Enforcement is typically tied with education to inform residents of the dangerous behaviors, ways to curb the behaviors, and explain why we perform high visibility enforcement.

WHY ENFORCEMENT? CAN IT WORK?



Dangerous Behavior	Enforcement Activity	Effect on Crashes
Drivers not yielding to pedestrians at crosswalks	Targeted driver enforcement at crosswalks	23% pedestrian crashes
Impaired driving	Publicized sobriety checkpoints	17% alcohol related crashes
Driver excessive speeding	Automated speed enforcement	19% reduction in severe collisions

If all U.S. communities had speed-camera programs like the one IIHS studied in Maryland's Montgomery County, more than **21,000 fatal or incapacitating injuries would have been prevented** in 2013.
